- 1. THIS COMPETITION IS OPEN TO PARTICIPANTS FROM THE AGE OF 18-35 YRS
- 2. PARTICIPANTS MUST RESIDE IN THE NORTH WEST PROVINCE
 - 2.1. THE ULTIMATE TALENT SEARCH IMPLEMENTATION APPROACH District Selections: Only top three (3) winners from each District will compete in the finals (and will be rewarded for being district finalists).
 - 2.2. The 12 finalists from all districts will perform at the MACSF Ultimate Talent Search showcase event, and grand finale.
 - 2.3. Only top three (3) from the twelve (12) will be selected for prices.
- MACSF will only accept entries from opening date of advert until a day before the district audition, 11h00am.
 - 3.1. Late entries are automatically disqualified.
 - 3.2. Participants can only audition once.
 - 3.3. The judges' decision is final, and no correspondence will be entered into.
 - 3.4. Participants must attach ID copy and a VALID proof of residence.
- 4. ANTI DOPING
 - 4.1. No alcohol, smoking and substance use will be allowed in any venue
- 5. HEALTH AND SAFETY
 - 5.1. Dressing rooms and other facilities must be kept neat and clean.
 - 5.2. Do not Littering. Please place your refuse in a refuse bin.
- 6. CODE OF CONDUCT
 - 6.1. All participants agree not to make any comments to the press or media on behalf of The Ultimate Talent Search, unless permitted to do so by Mmabana, Arts, Culture and Sport Foundation (MACSF).
 - 6.2. Participants will be given a minimum of 2 minutes for auditioning, additional time (if any) will be at the discretion of Judges)

7. INDEMNITY
